(Regarding Chief Minister's Jibon Prerana Scheme, 2025)

In pursuance of the notification issued by the Hon'ble Governor of Assam vide No. ECF No. SEED/655009/112, it is hereby informed to all concerned that under the "Chief Minister's Jibon Prerana Scheme", the Government of Assam will provide support to fresh graduates of the state. All eligible Fresh Graduates (2025 Pass-outs only) are advised to apply for the CM's Jibon Prerana Scheme through the DDIS portal on or before 30th November 2025.

Further, students who have applied for the Chief Minister's Jibon Prerana Scheme are required to submit the hard copy of the application along with the supporting documents to the institution on or before 30th November 2025 for verification purposes.

Supporting documents required.:

- Print out copy of Online Acknowledgement. i)
- Copy of Bank Passbook ii)
- iii) Copy of Aadhaar Card
- iv) Income Certificate (below Rs. 10 lacs per annum)
- v) Copy of Degree Completion Certificates including consolidated Marksheet & certificates.

Eligibility for Jibon Prerana Scheme:

- Fresh Graduates (2025 pass-out only) from Govt./Public Institution of State or Central situated in Assam (excluding Open Universities and Private Institutions).
- ii. Permanent Resident of Assam

Exclusions for Jibon Prerana Scheme:

- Candidates currently pursuing PG Courses.
- Beneficiaries of Mukhya Mantri Nijut Moina Scheme. ii.
- iii. Applicants with Professional/Vocational Courses.
- Applicants having any of the parents as a public office holder, government employee or iv. pensioner (However, having parents as Grade IV Govt. Employees are eligible for the scheme).
- The applicant's parents should not be registered as a contractor. V.
- vi. The applicant should not be employed.
- Applicant hailing from a family of professional with income of more than Rs. 10 lacs in a year. vii.
- viii. Applicants having any of the parents employed in public offices (MLAs, MPs, or Ministers)

Benefits of the Scheme:

Financial Assistance of INR 2,500/- per month for 12 months.
